#### 1. Introduction

Our website, <a href="https://www.endecocide.org/en">https://www.endecocide.org/en</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). #### 2. What are cookies?

## 3. What are scripts?






